### 2016-2017 INTERNATIONAL PRESIDENT BOB CORLEW

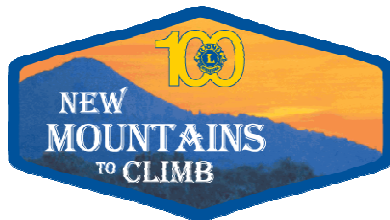
Chancellor Bob Corlew from Milton, Tennessee, USA, was elected to serve as president of Lions Clubs International in the association's 99th International Convention held in Fukuoka, Japan.

President Corlew is retired as councillor for the State of Tennessee and a professor at law.

A member of the Murfreesboro Noon Lions Club since 1978, he has held many offices within the association, including charter club president, zone chairperson, district governor, cabinet secretary and council chairperson. He has been instrumental in the chartering of a number of new clubs. Most recently, he worked to charter a new club comprised of lawyers and judges, which gained more than 75 members during its first year.

In recognition of his service to the association, he has received numerous awards including the Leadership Award, the Builder Key Award, three International President's Awards and the Ambassador of Good Will Award, the highest honour the association bestows upon its members. He is also a Vanguard of the Melvin Jones Memorial, a Progressive Lindsey-Jennings Fellow and a Progressive Melvin Jones Fellow.

In addition to his Lions activities, President Corlew has been active in the Boy Scouts of America, the Jaycees and the American Red Cross. He has also served a councilman in Milton and was a Major in the U.S. Army Reserve. President Corlew and his wife, Dianne, also a Lion and a Progressive Melvin Jones Fellow, have five children and five grandchildren.



President Bob has chosen the theme **NEW MOUNTAINS TO CLIMB** during his Presidential Year. This being the Centennial Year of Lions Clubs International, the theme is appropriate as there are several things to be done.

With the permission of the Sliema Council, Lions Club Sliema organised a fund-raising activity during the Arts Festival held during the weekend 16/17 July. People were asked to guess the number of balloons in a Volkswagen car (made available courtesy of Continental Motors) against a donation of one euro and having the chance to win Euro 100.

## KNOW MORE ABOUT LIONS



Quite often members ask questions about how funds raised from activities can be utilised. Lions Clubs International have a Policy of how such funds can be used. For the benefit of members hereunder are the relevant paragraphs about the "Use of Funds Policy".

### *General Policy on Funds Raised from Lions Clubs Activities:*

Funds raised from the public must be used for the benefit of the public and community in which the Lions Clubs serve. The International Constitution and By-Laws and Articles of Incorporation (the "governing document") provide that chartered Lions Clubs shall be not-for-profit of the individual club or its individual members. Consequently, no part of the net earnings of funds raised from the public shall benefit any individual Lions member, or other private individual or entity. These policies are intended to provide guidance for clubs to meet the purposes of the International Association of Lions Clubs. Key in determining the proper use of funds is considering transparency to the public and developing trust from the community in which the Lions operate. How Lions use funds must meet the legal and tax requirements for the local jurisdiction in which they operate.

- Definition of Public/Activity Funds. Funds raised from the public are the net earnings of income raised from activities open to the public, public contributions, bequests and money accumulated from invested public funds.
- Definition of Administrative Funds: Administrative funds are contributions from Lions through dues, fines, advertisement revenue, rental fees and other individual Lions contributions. These funds may be used for other public projects or for internal Lions use such as meeting and convention expenses, incorporation fees, audit fees,, newsletters, bulletins and other club and/or district operating and administrative expenses.

Direct Expenses of Fundraiser: Direct expenses of a public fundraiser may be deducted from the proceeds of the fundraiser to replenish the administrative funds used to hold the fundraiser.

This is not the first time that the Club has collected eye glasses to be sent to African countries. Over 30 years similar donations were made to Zimbabwe and in recent years hundreds of eye glasses were sent to Lions in France and Italy for onward despatch to other African countries. Such donations are appreciated by people in Africa since improving their eye sight is of importance and can many a time ensure that they could lead a better way of living.
