## **DID YOU KNOW?**

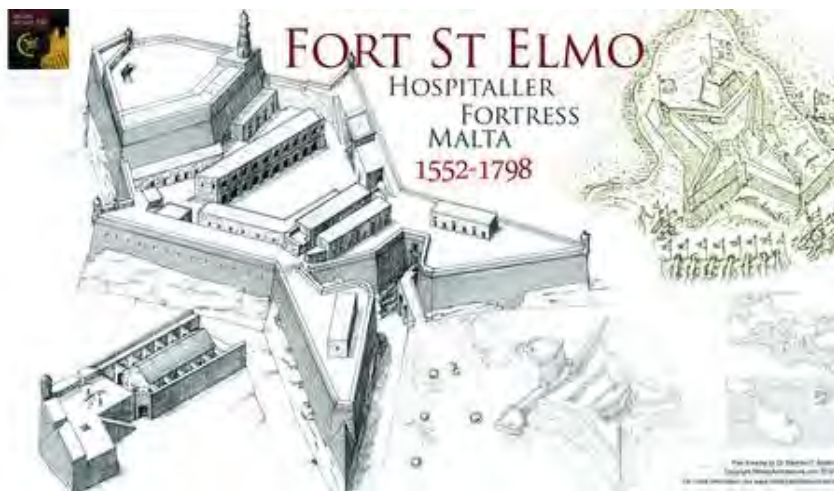

## THINGS TO KNOW

Each Lion Club appoints a Treasurer who administers the Club's funds. Normally a Club has two accounts the Public (Activity) Funds and the Administrative Funds.

The **Public (Activity) Funds account** is commonly known as the Philanthropic Account and is any funds therein are used solely for services of a philanthropic nature. According to Lions International statute, all funds raised from the public must be returned to public use, including money accumulated from invested public funds. The only deductions that may be made from the activity account are the direct operating expenses of the fundraising activity. Money accumulated from interest must also be returned to public use.

**Administrative Funds** are supported through contributions from members through dues, fines and other individual contributions.

The individual membership dues go into this account. From the annual dues paid by members, each Club has to forward the international dues of each member to Lions Clubs International at Oakbrook.

A Club may have other accounts as for example our Club has the Arts Fund, an account solely used to promote arts among youths. This was setup a few years ago and there is a Sub Committee whose members propose to the Board of Directors any project benefitting an individual or group to further his/her studies in arts.

It is important for members to note that the Club which is registered as a Voluntary Organisation has still to submit a yearly balance sheet to the Inland Revenue Department and also a balance sheet to the Director of Voluntary Organisations. This shows how important it is to keep accurate accounts. The Club is fortunate that for several years we have had capable and hard-working Treasurers and Lions who despite relinquishing the office of Club Treasurer continued to give advice and help the Lion acting as Club Treasurer.

Though a voluntary philanthropic organ each Lions Club must abide by the laws of the country.

## GUIDE DOGS FOR THE BLIND

One of the major projects undertaken by Lions worldwide is to provide guide dogs for the blind. In various countries Lions support this great project by donating funds to the various centres which train dogs.



One of these centres can be found in Limbiate (Italy) which is run on a professional basis training dogs not only for those in need in Italy but also for other countries. The Director of the centre is Lion Giovanni Fossati, a member of Lions Club Rho. He has a staff of 15 people who train the dogs

The idea of having such a centre in Italy was mooted by a military pilot who served in the Second World War and who lost his sight in an accident. From humble beginnings the centre is now fully established. It moved to its present locality in Limbiate in the Province

of Milano occupying an area of 25,000 square metres. Besides the Director the centre employs 15 persons who train dogs from the time they are brought to the centre as puppies.

The training of a guide dog takes about six months and costs approximately 25,000 Euros until the dog can be handed over to the person in need of a guide dog. The cost also includes the stay of the person who would be receiving a guide dog while he is at the Centre for training.

In March 1986 the President of the Italian Republic decreed the centre as "Ente Morale". As a result the Centre was able to obtain public funds for its day to day operations. However these funds are not enough, hence the centre obtains funds through donations made by various entities. 47% of these donations come from Lions Club in Multiple District 108 ITALY. Most of the Italian Lions Club make an annual donation thereby making it possible for the Centre to continue its noble work.
